Pre-Trial Work Pays Off

In the depths of Minnesota winter, a snowmobiler rode along a rural gravel road to his brother-in-law's house, planning to watch the Super Bowl. A freshly whitened landscape stretched in all directions, promising nothing but smooth sailing. The illusion, however, dissolved when the snowmobile hit a utility pole buried in the snow and both snowmobile and rider went flying.



Site Visits Important

The driver came to Maschka, Riedy & Ries shortly after the accident with a compression fracture in his back, a fractured kneecap and aggravation of previous injuries. Having struggled through a car accident and serious soft-tissue injuries without guidance just a year before, he called us within days. MRR immediately sent an investigator to the site, who photographed poles and evidence of the event in the snow. Legal staff visited the site with the client several times to understand what had happened and where.

Attention to Detail Makes Case for Snowmobile Driver

Pre-Trial Disputes

When the incident was brought to the attention of the utility company and subcontractor responsible for placing the poles near the road, discussion focused on two questions: Was the rider properly in the road right-of-way? and Were the poles in the road right-of-way, such that there was duty to warn of the poles? The utility company and officer on call insisted that the poles were not in the road right-of-way; our client and eyewitnesses said they were. Further dispute focused on whether injuries were caused by the snowmobile accident or the previous year's car accident.

for the trial. Many depositions were taken. To prove that the poles were in the road right-of-way, a surveyor mapped the site. Our client and his wife were prepared for direct and cross-examination and coached in trial procedures. Expert witnesses were sought and prepared to testify.

The Decision

At trial defendants offered to settle for \$20,000. The jury found that the contractor and utility company were largely at fault and liable for damages related to the accident and the spouse's loss of consortium. Our clients were awarded \$111,150.



Preparing for Trial

Because of its complexity, some lawyers may have chosen to settle this case, but MRR believed the client and believed in the firm's ability to make a case. MRR's Renee Rubish led intense preparation
