If you're hurt in a car crash talk to a lawyer. When you are injured in a car crash it is important to understand the interaction between your own health insurance, no-fault coverage and worker's compensation if you are on the job at the time. It is your no-fault medical coverage (usually \$20,000) which applies first before your health

insurance is required to pay. If at the time of the crash you are at work and have worker's compensation coverage, it is the worker's compensation coverage which applies first. Once your no-fault coverage is exhausted, your health insurance takes over payment of the bills. One important difference between no-fault coverage and health insurance or worker's compensation coverage is that both the health insurer and the provider of worker's compensation will want some or all of their money back from the liability carrier for the person who was at fault. Management and negotiation of this expected repayment can be a complex matter. Also, once you are involved in a crash, it is important to understand those benefits to which you may be entitled under your no-fault coverage or your worker's compensation coverage, depending on which applies. The benefits available under worker's compensation and no-fault are not identical. Also your station in life and whether you are a primary homemaker and/or earning a regular weekly salary may entitle you to benefits other than just a percentage of your loss of income.

Timely Decisions Benefit Client

Frustrated by many wrong turns, a woman pulled her car to the curb and stepped out to ask for directions. Noticing a leashed Rottweiler near the man she planned to talk to, the woman asked if it was safe to come closer. He wasn't sure, so she stayed several yards away on the sidewalk. As the two discussed a route



to the local FedEx office, the dog circled behind the woman without warning and jumped on her back. The man yanked the leash, and the dog grabbed her arm. He pulled the leash again and the dog bit down, shaking her arm as if capturing prey. When freed, the woman was rushed to a hospital where MRR Partner Renee Rubish met her three days later.

Turning to a Lawyer

This client was not sure if she needed a lawyer. She asked for a consultation, but had a low opinion of trial lawyers and hoped to represent herself as she had in a prior injury case. Injury's Long-Term Effects Impact Settlement

MRR as Liaison With Insurers

While our client received proper medical attention, we made contact with the insurance company about medical payments and supplemental income to cover her earnings loss. She followed doctors' instructions, tended to the large wound on her forearm and exercised to regain motion. We reported her medical progress regularly to insurers. When the company asked for statements and photographs, we arranged meetings.

Reality Drives Settlement

MRR This client was eager to settle her case and put the incident behind her, but we encouraged her to let us monitor the scar and consequences of the injury as it healed.

Doctors found nerve damage and numbness, and medication was prescribed for pain. Tingling, hypersensitivity and spasms persisted near the large scar and throughout our client's arm. Motion was restricted and a weakened grip limited work, daily tasks and hobbies.

With these persistent issues clear, Rubish approached the insurance company for a settlement. No dispute existed about responsibility for the injury, so the question was the value of the loss. To best represent her client, Rubish drew on her own experience and consulted with MRR colleagues to name the settlement value: \$85,000.
